### Description

The shower glass is made of tempered glass, polished aluminium frame, seals for water tightness, chrome handle/s, certified 6mm/8mm/10mm safety glass.

The door (and return, if applicable) comprises toughened safety glass complying with AS/NZS 2208, with nano coating. A Pivot, Hinged or Sliding shower door (and returned if applicable), intended for personal showering in residential building.

## Scope of Use

For interior installations in residential buildings, with timber or concrete flooring.

Install as a complete Acrylic Shower Enclosure (comprising Acrylic Shower Tray, Shower Liner & Shower Door or return if applicable) or as a Tile Option Shower Enclosure (comprising Shower Door Set or return if applicable only - Waterproofing & Tiles are not included).

#### Condition of Use

Lennox Bathroom Shower Glass door (& return, if applicable) must be installed and maintained in accordance with our supplied instructions.

Special attention must be paid to the specific requirement for each joint - please refer to the installation instructions for further information.

The tapware & waste must be installed by a Registered Plumber. The maximum permitted temperature of water at the shower outlet is 50 degrees Celsius.
