Lennox Bathroom Limited has provided this declaration to satisfy the provisions of Schedule 1(d) of the Building (Building Product Information Requirements) Regulations 2022.

## Product/system

#### Description

The shower liner is made from a single, folded piece of 2.0mm acrylic capped ABS sheet 1900mm high, it's a one piece no joints to prevent the water leakage. The recommended shower liner adhesive is Sika® Showerbond. Sanitary Grade Acrylic features a high gloss surface for ease of cleaning.

The surface of the shower line is white flat sheet, no moulded, with transparent protective film.

All sizes are nominal and specific availability varies according to the choose range.

### Scope of Use

For interior installations in residential buildings, with timber or concrete flooring.

Install as a complete Acrylic Shower Enclosure (comprising Acrylic Shower Tray, Shower Liner & Shower Door or return if applicable) or as a Tile Option Shower Enclosure (comprising Shower Door Set or return if applicable only - Waterproofing & Tiles are not included).

Hot water must be supplied to this sanitary fixture via adjacent tapware.

#### Condition of Use

Lennox Bathroom Shower Liner must be installed and maintained in accordance with our supplied instructions, and must be installed using only Sika® Showerbond adhesive. The substrate must not have been previously plastered, sealed or painted. Gaps must be left in the adhesive pattern to allow solvent release. The edge of the wall liner should not be sealed until the adhesive has cured.

Special attention must be paid to the specific requirement for each joint - please refer to the installation instructions for further information.

The tapware & waste must be installed by a Registered Plumber. The maximum permitted temperature of water at the shower outlet is 50 degrees Celsius.
